Mountain Bike Australia Limited ('MTBA') Terms of Use Statement

By using this Service, you agree to indemnify MTBA and its officers, employees and agents from and against all actions, claims, suits, demands, damages, liabilities, costs or expenses whether direct or indirect (arising out of or in any way connected to the use of the Service by you).

1. Agreement to the Terms of Use (the 'Service').
